In August of 2020, the State of Nevada entered into a Stipulated Consent Judgment in the case of *Davis v. State*, which requires that the Department of Indigent Defense Services (DIDS) publish certain statewide data related to indigent defense on a quarterly basis. These reports must include: public defense caseload numbers, organized by type of case; attorney and staff hours, investigator hours, and expert hours spent per case; total number of motions to suppress filed and litigated; number of trials over the reporting period; and private workload, measured in attorney hours.

This was an exceptional challenge for a number of reasons, not the least of which was that much of this data had never been recorded in many of Nevada’s counties. Also, DIDS was a new department, tasked with building itself at the same time it was working to meet the rigorous mandates of the *Davis* settlement, all during a global pandemic.

There were many other pieces that needed to come together in order for this report to exist. The backstory begins with the Board on Indigent Defense Services successfully navigating the multi-year process of creating permanent regulations. These regulations facilitated the necessary data collection by defining what information was to be gathered and setting forth its uniform collection using the case management system to be provided to all indigent defense practitioners by DIDS. Finally, the regulations require that counties mandate the reporting through their Indigent Defense Plans.

DIDS, with the assistance of Enterprise IT Services (EITS), then chose and customized a case management system to meet Nevada’s time-tracking and reporting needs. DIDS rolled out the system, LegalServer, to all qualified indigent defense providers in the rural counties and provided twice-weekly training for the system in June of 2021.

In addition to DIDS’ efforts in compiling this data from 15 counties, these reports also represent the unprecedented efforts and cooperation of indigent defense providers across Nevada’s 15 rural counties. Despite the challenges that COVID-19 presented to these attorneys and their staff, and despite the fact that these reporting requirements meant additional allocation of time and human resources, most rose to the occasion.

This data does more than just comply with the reporting requirements of *Davis*, it give us new information. DIDS will use this information to provide clearer pictures of how hard these providers work for Nevada and identify where additional resources are needed, so we can continue the work of creating a better support network and more access to resources for all Nevada communities. And this is just the beginning. Working together with our network of indigent defense providers across the state, we will continue to make Nevada’s communities stronger than ever.

Douglas County contracts with five private counsel to provide high quality indigent defender services. The Douglas County Appointed Counsel Program Coordinator, Derrick Lopez, oversees the assignment of cases to the contract public defenders and works in coordination with the Department of Indigent Defense Services.

Douglas County is currently seeking qualified applicants for two open attorney contract positions. Douglas County recently increased the financial compensation for the contract to \$265,000 from \$195,833.33. Douglas County has also increased the hourly rate for appointed indigent defense counsel from \$100 per hour to \$150 for felonies and gross misdemeanor and \$125 for misdemeanor and juvenile representation.

Limited data has been received from the Elko County Public Defender's Office as Elko County contracted with the Tyler Technologies software system prior to LegalServer being released. Elko county is exploring creating a software bridge between the two systems so that the office can come into compliance with the reporting requirements.




