The mission of the Nevada Department of Indigent Defense Services (DIDS) is to assist Nevada counties in developing quality, equitable, and sustainable indigent defense systems that strengthen local communities and meet or exceed the state and federal constitutional guarantees that protect each of us.

<u>GOALS</u>

The goals of DIDS are to build a strong and resilient statewide network of effective indigent defense providers and to support them with regular education, training, and other defensespecific resources, including experts, investigators, social workers, and other valuable tools. DIDS also seeks to create a centralized resource center that provides holistic defense services and complex litigation assistance. DIDS is working to create a pipeline program through Boyd School of Law at UNLV, to bring more qualified indigent defense attorneys into the rural areas.



Holistic Resource Center

- Criminal Justice + Social Justice
- Connects Public Defenders and their clients to social worker / behavioral health / substance abuse
 - HRC will provide aid at Intercept 2 on the Sequential Intercept Model (SIM) developed by SAMSHA Gains Center.
 - Catch those falling through gaps (concern of FASTT)
- Provides Rural Attorneys with same resources as in larger counties and Prosecutors (Davis)
- Relieve Burden DHHS (Lakes Crossing) with setting up Competency Evaluations
- Reduce Jail Burden (facilitate remote evaluations)
