Dear Director Ryba,

Please accept this as my letter of interest to serve as the Nevada State Public Defender. I believe my background as both a dedicated public defender, as well as my experience as deputy general counsel in the Office of the Governor, makes me uniquely qualified to navigate the intricacies and challenges of state government and lead the office into a new era.

I received my Juris Doctor degree from the University of San Francisco School of Law and have focused my career on fighting constitutional issues in complex cases implicating civil rights and civil liberties. During my time as a felony trial deputy with the Washoe County Public Defender's Office, I carried an extensive caseload and represented individuals at all stages of the criminal proceedings, in cases ranging from theft to first degree murder. In this role, I zealously litigated constitutional issues in a community where those protections are regularly infringed upon. This came during the Covid-19 pandemic, which resulted in court closures. During this time, I relentlessly litigated for my clients to be tried in-person. Through this advocacy, I successfully tried two jury trials to completion during the pandemic, including a five-count category B felony case for which my client was acquitted on all charges. I also successfully advocated for in-person preliminary and sentencing hearings. This included sitting as co-counsel for a two-day Category A Murder preliminary hearing. Beyond this, I conducted regular preliminary hearings and bench trials, and negotiated cases.

My commitment to indigent defense dates back to my time as a law clerk in the Federal Public Defender's Capital Habeas Unit, where I assisted in representing death row inmates in post-conviction appeals, submitting work to the United States Supreme Court. My work included implementing and conducting a state-wide empirical study on capital sentencing practices and subsequently drafting a *Furman* claim for use in ongoing petitions.

I subsequently spent years working closely with my mentor during my time at Hamasaki Law, a premier civil rights and criminal defense firm in San Francisco, I had exceptional opportunities to develop my litigation skills in state and federal court, drawing on broader themes and academic research to further my client's interests. For example, I conducted research and drafted *in limine* motions to exclude rap lyrics as evidence of gang involvement, focusing on First Amendment protections and highlighting the racist and inherently prejudicial nature of using rap lyrics as evidence of criminal activity. I was also given the opportunity to work on high-profile wrongful death, defamation, and First Amendment violation lawsuits, for which I conducted extensive research, drafted pleadings and other moving papers, and prepared witnesses for deposition and trial. In criminal matters, I argued pre-trial motions, achieving dismissals, represented clients at pretrial hearings, and prepared misdemeanor and felony cases for trial.

I have since had the pleasure to serve as the Deputy General Counsel to Governor Steve Sisolak where I expanded my skillset beyond the courtroom. In this role, I identified policy needs and worked directly with state agencies, state and local officials, and other stakeholders to implement these policy goals to (1) lead effective change and (2) lead individuals. For example, I identified the need to expand forensic bed capacity for incompetent defendants across the state. I then worked directly with a diverse group of stakeholders, including district attorneys, public defenders, judges, county officials, and state lawmakers to address the need. As a result, I successfully testified before the Interim Finance Committee for approval of a \$55 million forensic capital expenditure. In this role, I also oversaw agencies through crisis, navigating conflict management among high level cabinet members and working to problem solve issues for the betterment of the state. This included navigating and coordinating the response to the escape of a convicted person from the custody of the Nevada Department of Corrections.

My longstanding passion for indigent defense dates to my time interning at the Public Defender's office as an undergraduate student. The talent, dedication, and commitment to justice promoted by the Department of Indigent Defense is in line with the guiding principles of my work: to advance the well being of my community. I believe my academic and professional training, combined with my passion and dedication, make me a strong candidate to lead this office into the future. I understand where challenges lie on the road ahead, but I also understand how to navigate those challenges and zealously advocate for my clients, and the office, in and out of the courtroom.
