## Please state your Complaint or Recommendation:

I was initially contacted on 12-27-23 by Attorney Nadine Morton to perform forensic analysis on a murder case out of Nye County. The Defendant is John Vithoulkas (23CR02074). DIDS first approved \$15,000 for my involvement in the case. I submitted my first invoice for \$9687.50 on 4-10-24. I received a check for that amount from Nye County on 6-20-24 (about 2 months and 2 weeks later). I then performed additional forensic work and examinations and evaluations on the case. It was expected that I would be testifying at trial and additional funds in the amount of \$3000 was approved by DIDS for me to complete my analysis and travel to Pahrump to testify. I learned from Ms. Morton on

8-6-24 that the case was negotiated (see my Invoice #2). I submitted a second invoice in the amount of \$2500 to Nadine Morton on the same date (8-6-24). Herein lies the problem - I have not been paid for my second invoice. I called and spoke with Bet-Nimra Torres Perez (who has been very helpful and understanding). At her recommendation, I contacted Ms. Morton who advised she submitted the paperwork for me to be paid. Ms. Perez sent an email to Lorina Dellinger from Nye County (and cc'd me) on 9-13-24 inquiring about the situation. Ms. Dellinger replied that she has no record of receiving the documentation. I have a copy of an email by Ms. Morton dated 9-17-24 where she sent (or resent) the required paperwork to Ms. Dellinger in Nye County (this could be a second submittal?). On 9-23-24, I called again and spoke with Ms. Perez. She sent another email to Ms. Dellinger asking if she received my invoice. As of this writing on 9-30-24, Ms. Dellinger has not responded to Ms. Perez. I don't know for sure where the mix-up and problems lie, but it is clear that Ms. Dellinger does not respond in a timely manner to inquiries from DIDS. As I believe (and I am told by many attorneys) that I am providing a valuable service (forensic expertise) to DIDS, I would like to be paid in a timely manner for my time and effort. It is going on 2 months since I submitted my second invoice on this case, and I would like to be justly compensated. Please call me if you have questions or need further clarification.
