RESOLUTION

A resolution making an allocation from the Interim Finance Committee for the support of the Department of Indigent Defense Services: and providing other matters properly relating thereto.

WHEREAS, Pursuant to section 80 of chapter 310, Statutes of Nevada 2021, the sum of \$1,169,427 for Fiscal Year 2021-2022 was appropriated from the State General Fund to the Interim Finance Committee for allocation to the Department of Indigent Defense Services to fund costs in excess of the estimated county maximum contribution amounts for the provision of indigent defense services for the 10 rural counties defined in the Davis v. State (Nev. First Jud. Dist. Ct. Case No. 170C002271B (Aug. 11, 2020)) consent judgment (Churchill, Douglas, Esmeralda, Eureka, Lander, Lincoln, Lyon, Mineral. Nye and White Pine counties): and

WHEREAS, Pursuant to section 80 of chapter 310. Statutes of Nevada 2021, the Department of Indigent Defense Services has submitted a request to the Interim Finance Committee for an allocation of \$308.827 from the money appropriated from the State General Fund pursuant to section 80 of chapter 310, Statutes of Nevada 2021, to reimburse Eureka, Lyon. Mineral and White Pine Counties for costs in excess of the estimated maximum contribution amount these counties must pay for the provision of indigent defense services; and

WHEREAS, Pursuant to section 80 of chapter 310. Statutes of Nevada 2021, the money appropriated by section 80 of chapter 310. Statutes of Nevada 2021 may only be allocated by the Interim Finance Committee upon recommendation of the Governor and upon submittal by the Department of Indigent Defense Services of financial reports demonstrating costs in excess of a county's maximum contribution formula. and up to the amount approved by the Board on Indigent Defense Services for that county; and

WHEREAS. Pursuant to section 80 of chapter 310. Statutes of Nevada 2021, the Department of Indigent Defense Services has submitted the necessary documentation and the Governor has provided the necessary recommendation; and

WHEREAS. Pursuant to section 80 of chapter 310, Statutes of Nevada 2021, the Interim Finance Committee has determined that the sum of \$308,827 should and may lawfully be allocated to the Department of Indigent Defense Services for this purpose; now, therefore, be it

RESOLVED BY THE INTERIM FINANCE COMMITTEE. That pursuant to section 80 of chapter 310, Statutes of Nevada 2021, the sum of \$308.827 is hereby allocated from the Interim Finance Committee to the Department of Indigent Defense Services to reimburse Eureka. Lyon. Mineral and White Pine Counties for costs in excess of the estimated maximum contribution amount these counties must pay for the provision of indigent defense services; and be it further

RESOLVED. That any remaining balance of this allocation must not be committed for expenditure after June 30, 2022, by the Department of Indigent Defense Services or by any entity to which money from the allocation isa granted or otherwise transferred in any manner, and any portion of the money remaining must not be spent for any purpose after September 16, 2022, by either the Department or the entity to which the money was subsequentlya granted or transferred, and must be reverted to the State General Fund on or before September 16, 2022; and be it furthera

RESOLVED. That the State Controller is hereby directed to transfer the amount so allocated.
